LaRue named associate dean

L. L. LaRue, business manager at The University of Texas of the Permian Basin, has been named associate dean for administration at TCOM. His appointment is effective Oct. 1 and was approved by the North Texas State University Board of Regents at its regular meeting Aug. 27.

In announcing the appointment, Dean Ralph L. Willard said, "Mr. LaRue will serve as chief fiscal officer for TCOM and be responsible for administration of fiscal affairs and all non-academic affairs in the college. I'm delighted we will have joining us a man of Mr. LaRue's experience in state university fiscal matters. We know he will add strength to the leadership team we are building at TCOM."

President C. C. Nolen said, "We have followed the career of Mr. LaRue for a number of years and believe his experience and strength will enhance this developing osteopathic medical college immensely."

Prior to joining The University of Texas of The Permian Basin, LaRue was vice-president for fiscal affairs

at Texas Woman's University, where he also had served as chief accountant, auditor and comptroller. He received a bachelor of business administration degree from NTSU in 1947 and then did graduate work at The University of Texas at Austin.

LaRue served in the U.S. Army from 1940-45 and was in the European Theater of Operation.

The new TCOM associate dean holds membership in the Texas Association of State Senior College and University Business Officers and the Southern Association of College and University Business Officers.

Governor appoints new regent

Albert Gates of Laredo was named to the North Texas State University Board of Regents Sept. 10 by Gov. Dolph Briscoe. The Board of Regents serve as TCOM's governing body. Gates was appointed to a six-year term expiring May 25, 1981. He replaces Davie James Lawson of Dallas, whose term expired.

Gates is president of Espejo Corp. and is in the cattle-raising business. He attended Texas A&M University, Texas A&I University and the University of California at Los Angeles. He is a director of the Texas and Southwestern Cattle Raisers Association, a Mason and president of First Federal Savings and Loan of Laredo. Gates and his wife, Dorothy Jean, have four children.

Regents approve master plan site

The North Texas State University Board of Regents, acting as TCOM's governing body, authorized President C. C. Nolen to request approval from the Coordinating Board, Texas College and University System and other appropriate agencies to establish the master plan land requirements in Fort Worth for TCOM. The action was taken at the regular meeting of the regents Aug. 27. The land requirements are to include the following sites in addition to the land presently owned by TCOM: (1) the west end of Block 6 bounded by Darcy Street, Clifton Street and Camp Bowie Boulevard, consisting of lots 8, 9, 10, 11, 11A, 12, 13, 14, 15, 16 and 17, total 1.8 acres, and (2) all lots in Block 7 bounded by Montgomery Street, Modlin Avenue, Clifton Street and Mattison Avenue, total 4.54 acres, thus adding a total of 6.34 acres of land to the 4.1 acres presently owned for a total planning perimeter encompassing 10.4 acres.

During the NTSU portion of the

regents meeting A. M. Willis Jr. of Longview, a member of the Board of Regents since 1965, was unanimously elected to his eighth one-year term as chairman of the governing body. Elected to his first term as vice-chairman was E. Bruce Street of Graham. Dr. Roy Busby, assistant to the president, was reelected secretary.

In other action the regents:

- *authorized President Nolen, as president of TCOM, to enter into a contract with the Health Management Corporation for a medical services, research and development plan for the medical school;

- *approved the appointments of the following faculty: Dr. L. L. Bunnell as professor and chairman of the Department of General and Family Practice, Dr. Richard Baldwin as associate professor of general and family practice, Dr. Peggy Hall as instructor of general and family practice, Dr. Edward T. Newell as professor of general and family practice, Dr. Dan Waddell as assistant professor of medicine, Dr. Roger W. Roberts as instructor of medicine, Dr. John Locke as assistant professor of medicine, Dr. Richard Lynn Powell as assistant professor of surgery and Dr. Lloyd Kent Weldon as instructor of surgery. All appointments were effective Sept. 1 with the exception of Dr. Bunnell. His appointment is effective Oct. 1.

- *approved several budget adjustments and transfers for 1976-77;

- *authorized the administration of TCOM to make available to those employees desiring to participate the deduction of social security withholdings, with the provision that all persons employed on or after Sept. 1, 1976, be required to participate in the social security withholding program;

- *authorized President Nolen to "grant, sell and convey" to Lone Star Gas Company 100 square feet of land on the TCOM campus as required for the relocation of gas distribution facilities for the benefit of TCOM.

Sustainers to be honored

Luibel, American Osteopathic Association president; Tex Roberts, Texas Osteopathic Medical Association executive director; Dr. Shelley Howell, TCOM Alumni Association president; Dr. Paul Livingston, TCOM Alumni Association president-elect; and Col. James G. Sanders, Carswell Air Force Base Hospital chief-of-staff.

Doug Morrow, a fourth-year student-doctor, will present a musical program at the pre-game dinner.
