## Dr. Budd accepts TCOM post

Dr. Michael L. Budd, a project staff member in the Office of Medical Education Research and Development (OMERAD) at Michigan State University, has been named director of admissions, effective July 1. Earlene McElroy, who has been serving as acting director of admissions and registrar for over a year, will become registrar and assistant director of admissions.

Dr. Budd, who has been active in the development of admissions procedures at MSU-College of Osteopathic Medicine, received his Ph.D. degree in higher education with minor emphasis on medical education from MSU in 1975, an M.A. degree in English from the University of Michigan in 1970 and a B.A. degree in English and Latin from Albion College in 1968. His dissertation was on research in instructional methodology and has been reported at the Association of American Medical Colleges.

While he was a Fellow in the OMERAD and working toward his doctor's degree, Dr. Budd worked with admissions projects in the College of Osteopathic Medicine and College of Human Medicine, student affairs and physician-educator program.

Dr. Budd has served on the Promotion and Tenure Committee and Fellow's Admission Committee at MSU. He holds membership in the Eaton Rapids Education Assn., Michigan Education Assn. and National Education Assn.

The new director of admissions is married and he and his wife, Lynn, have two children, Amy and Richard. Dr. Budd is the son of Dr. Linton Budd, a practicing osteopathic physician in Carson City, Mich.

## Abe Herman joins Dean's Council

A. M. "Abe" Herman, one of the nation's leading authorities in the area of law and the press, has been named to the TCOM Dean's Advisory Council. Herman's appointment to a two-year term was approved at the June 3 meeting of the North Texas State University Board of Regents.

Herman has specialized for many years in newspaper, radio and television libel and is the author of "Freedom of the Press." He was graduated from The University of Texas at Austin in 1927 with a doctor of jurisprudence degree. A member of the Fort Worth-Tarrant County Bar Assn., State Bar of Texas and American Bar Assn., Herman was admitted to practice before the United States Supreme Court in 1948.

Herman served as legal counsel to TCOM during the time it was a privately supported college. He is general counsel for the Amon G. Carter Foundation and Fort Worth Osteopathic Hospital.

## Regents approve budget

At the North Texas State University Board of Regents regular meeting June 3, the regents, acting as TCOM's governing body, approved a \$6,877,881 budget for the 1976-77 academic year.

The board also approved the president's recommendations for the personnel changes including the hiring of Dr. Russell Gamber as associate professor of general and family practice effective Sept. 1, Dr. Michael Budd as director of admissions effective July 1, Elizabeth Peterson as accountant II effective July 1 and either an accountant I or II, effective July 1. Approval was also given for the reassignment of Dr. James B. Reeves from assistant dean, basic health sciences, to a full-time teaching position as professor of microbiology. In other action the regents approved:

- \* alterations to the clinic at 3513 Mattison St. at \$20,000, and

- \* alterations to the Camp Bowie Clinic for the department of obstetrics and gynecology at \$4,500.

## Development office makes request

In order for there to be a complete accounting of gifts to TCOM, all monies given to TCOM, including memorials, should be channeled through the development office, according to Ray Stokes, director of development. Stokes said any special requests of donors will be honored and a restriction placed on the gift, if so stated.

"Whenever possible TCOM deposits its donations, pledges and memorials in one of three funds in the North Texas State University Educational Foundation, namely the Excellence Fund, the Loyalty Fund and the Memorial Fund. Otherwise, the gift goes into the general fund or a restricted fund for a specific purpose," Stokes said.

Stokes explained that unrestricted large gifts are deposited in the Excellence Fund for capital purposes and monies deposited in the Loyalty Fund are used for maintenance and operational expenses not clearly defined as budgetary items approved for state funding. Memorials, he said, will be expended appropriately at the discretion of the president and Board of Regents.

A gift of \$1,000 or more entitles the donor to membership in the President's Council and TCOM Sustainers, he said.
